Schools of Choice Notice

Lakeshore Public Schools announces that it is opening the application period for non-resident enrollment as a Schools of Choice student for the 2017-2018 school year.

Non-Resident Students Eligible to Apply:

The non-resident student must be a resident of another district within Berrien County.

Application Deadline: All Schools of Choice Applications will be accepted beginning Monday, May 1, 2017, through Friday, May 19, 2017. Parents will be notified no later than Friday, June 2, 2017, regarding the status of their application.

General Information:

1. Preference is given to siblings of students already enrolled under Schools of Choice.
2. If your child completes the current school year at Lakeshore and then moves outside the district boundaries, they must complete a Schools of Choice application in order to become eligible as a Schools of Choice student. Previous attendance does not guarantee acceptance, which is based on availability within the grade level.
3. All children within a family that apply are considered on an individual grade level basis.
4. If we receive more applications for a grade level than openings posted, a random drawing will occur.
